Name: Prince Kūhiō Commemorative Parade

The parade honors the accomplishments of Prince Jonah Kūhiō Kalaniana'ole, founder of the Hawaiian Civic Club movement and proponent of the Hawaiian Homestead Act of 1920. A unique parade, it honors the dedication and commitment of a multitude of individuals and organizations who work year-round to practice and to perpetuate the Hawaiian culture and who enhance the welfare and well-being of the Native Hawaiian community. Malihini and kama'āina, alike, learn about the work of the Hawaiian Civic Clubs, Royal Societies; the Department of Hawaiian Home Lands; Hawaiian Homestead Associations; the Office of Hawaiian Affairs; Alu Like, Inc.; the Queen Lili'uokalani Children's Center, and numerous community organizations, halau hula, and marching units. Each year members of the Royal Societies (Royal Order of Kamehameha, Ka'ahumanu Society, Hale O Nā Ali'i, and Mamakakaua) also participate. Rare Hawaiian flags of the Hawaiian Kingdom are

Services are attended by the Benevolent Royal Societies, Ali'i Trusts, Hawaiian Civic Clubs and the public.

President Paris' Extraordinary Action

At the February 9th general membership meeting President Makana Paris informed members of the extraordinary action he took, without board approval or the general membership's approval, in submitting testimony before the state legislature on Senate Bills 328 and 673. Both bills propose a constitutional amendment to amend the timeframe to renew the term of office of a justice or judge and require consent of the senate for a justice or judge to renew a term of office.

The President noted, "...extraordinary action is only taken during things that are so timely and necessary that it threatens the very existence of our civic club." He followed up his announcement by reading, in its entirety, the testimony (below) submitted to the Senate Committee on the Judiciary and Labor (JDL).

"The Prince Kūhiō Hawaiian Civic Club does NOT SUPPORT the passage of SB328 and SB673.

The Club supports an independent judiciary. An independent judiciary is key to: a truly democratic system with safeguards against despotism; protecting the rights of the minority; maintaining a balance of powers between our branches of government; maintaining public trust in our government; and providing predictability in rulings that spurs economic activity. Moreover, an independent judiciary is critical to the enforcement of the Hawai'i State Constitution, including its unique provisions protecting the Environment and recognizing the traditional and customary rights of Native Hawaiians.

The founding fathers of the United States of America understood that a judiciary must be able to apply the law freely and fairly for a free society to prosper. The people of Hawai'i similarly expressed their will in the 1978 Hawai'i State Constitutional Convention – where the delegates enshrined judicial independence in Article VI, Section 3. After great deliberation, the delegates specifically intended to insulate the judiciary from political pressures by establishing a new judicial selection committee and empowering it, in its the sole discretion, to renew the terms of judges and justices.

Subjecting judges and justices to multiple confirmations before the Senate eviscerates that intent and jeopardizes the judiciary's ability to make decisions based solely on the letter of the law without the influence of popular politics or fear of retaliation

Meanwhile, the judicial selection committee has proven effective in fostering both judicial independence and public confidence in judicial rulings in Hawai'i. The committee limits the influence of the Executive, Legislative, and Judicial branches, as well as allows for measured public input from the legal community and beyond. In so doing, the committee limits the amount of influence that any one branch has over the renewal of judges and justices.

The judiciary does not require further checks on its power, for it is sufficiently balanced with the other branches of government, given both mandatory term limits for judges and justices and the control of its funding by the Executive and Legislative branches. Mahalo for fostering a strong, free, and democratic society by guaranteeing the independence of the judiciary."

Keone Nakoa, Resolutions Committee Chair, provided a brief update on the results of attending the JDL committee hearing and their meetings with senators. Members subsequently approved a motion to support the President's extraordinary action.

PKHCC Retreat Helps Define Hui's Focus

"When did you join the Prince Kuhio Hawaiian Civic Club (PKHCC)?" "What issues were present when you joined the PKHCC?" "Why are you here at PKHCC?" "What do you value about PKHCC?" These were the four questions facilitator and Oahu Council Chair Roth Puahala queried PKHCC executives and members in attendance at the February 4th Retreat in Punalu'u.

During their report to the PKHCC general membership on February 9th, the Strategic Planning Committee presented a brief report on the retreat in Punalu'u. The highlight from the report focused on the need to continue capacity building through the concepts of "Pilina" or relationships, "Kuleana" or responsibility, "Hana" or action, and "Kono" or invitation.

Facilitator Puahala and members in attendance at the retreat shared their mana'o on the experience. Member Momi Cazimero commented on her thoughts on the role of mentoring moving forward, "Very often when you talk about mentoring, it usually means the older teaching the younger...but in my experience in the last few days, I've learned from the young people..."

Member Keone Kuoha, whose team created the Pilina Flow Chart crafted around the question of what do you value about PKHCC, stood to provide an explanation of how the chart reflected our values, but also the strategy to engage more folks and move forward. Member Kuni Agard expressed sincere mahalo to the Strategic Planning Committee, Programming Committee and Aaron Mahi for the gifts of their 'ike, manama, and hana that made the retreat possible. He especially emphasiszed the makana of a club 'oli (next page) gifted to PKHCC by Aaron Mahi.

"The objective of the retreat, again, was to strengthen and deepen the piling of participants...engage in the collective discovery and learning of [kuleana], and then [to] launch a two-year plan [expedite this]

President Makana Paris closed by reflecting on his conversation with member Matthew Gumapac. "He was profoundly impacted by the humility of the members in this club. And it's true because in the 'Aha Hui Sivila we have masters in their crafts, in their various 'ike that they hold...How we act when we have masters around us is amazing. We are not so presumptuous that we think we know everything, we are willing to listen to the thoughts and opinions of others, we're willing to discuss, we're willing to disagree and to continue to share aloha when we disagree...And that's one of the reasons I'm still here"


